# **Projects Update**

We mentioned three projects in July's newsletter (hymnals for three churches in Northern Chihuahua, Mexico, school supplies for 50 children in/near Acuña, Coahuila, and building three houses near Acuña in October). Our prayers on these projects have been answered in mighty ways. Here's an update on each:

### **Hymnals**

We mailed our last newsletter on Tuesday, July 18. Just two days later, after barely enough time had passed for the newsletters to be delivered locally, I received a call asking whether I had received any donations to help pay for the hymnals. When I replied that we hadn't received anything

yet toward the hymnals, we were pledged the entire amount needed to secure them.

Wow, I thought! This is a wonderful, immediate answer to prayer!

It gets better!

## School Supplies

On the same day that I received the pledge covering the cost of hymnals, I returned home to check the afternoon mail and found a check covering the entire amount needed to purchase 50 sets of school supplies! This check had actually been written and mailed the day before!

In two days, God had taken care of two very special needs for our friends in Mexico by moving in the hearts of two of our

wonderful supporters here in Clifton, TX.

It gets even better!

#### **Building Projects**

As you may recall, we had three prayer requests in respect of our building projects: (1) sufficient funds, (2) enough workers, and (3) God's direction on recipients.

First, an update on what has turned out to be the easy part. We now have 39 people tentatively signed up for the trip (12 ladies and 27 men). We're almost at capacity, as the part of the men's dormitory allocated to us (at Camp Get-

semani, just outside Acuña) has only 30 beds. Please let us know if you'd still like to come. The camp cost is \$8 per person per night, and we will share the food costs among the group (estimated to be around \$50 per person for the entire trip).

We have, with your prayer support, been praying for clear guidance on both the number of houses (as dictated by the funds received) and the persons for whom we are to build. We now believe that God has provided His directions on these issues, and again He did it as a wonderfully clear answer to prayer.

I had a telephone conversation last week with our brother

Charles Knaack in Del Rio about the people for whom we ought to build. We discussed one lady in particular at some length, as Charles described to me how God had laid it on his heart to help her.

After our conversation, I asked God to make it <u>really</u> clear to me (I'm a bit thick at times) whether we were to help this lady. Specifically, I asked for enough money for the house to be pledged to us quickly, since at the time we had collected/pledged enough for just over 1 1/2 houses. About an hour later I got an e-mail pledging an additional \$5,000 to the process! Since a single house is estimated to cost \$5,200, it seemed to me that God's directions were


more than clear. "Get moving, my son, and build this lady *one* of the *three* houses I want Grace of Giving to build this year."

Specifically, we now have in hand or pledged to us \$13,083 of the \$15,200 we need to build three houses. Our deadline for receiving all of the funds is October 1, so that we can get the money to our coordinators in Mexico in time to ensure that the necessary materials are all purchased before we begin building on October 23rd. Please continue to pray with us that the rest of the funds will be forthcoming in a timely fashion.

our year-to-date numbers:

- Receipts (excluding those designated for house building): \$33,429.91
- Project Costs (excluding travel and admin costs): \$52,562.19
- Deficit (funded by Directors): \$19.132.28

Our fund-raising approach is simple. We make the need known. God takes care of working on people's hearts.

We would appreciate your prayers that Grace of Giving's financial needs would be met by God's providence, in whatever manner He chooses!
