### **2007 House Building Mission Trip**

As this newsletter is being printed, we are 10 days from departing for Acuña and Jimenez, Coahuila, Mexico, for our annual house building mission trip. Our emotions are admittedly somewhat mixed and range from excitement at the prospect of serving God in such a tangible way to a bit of fear of the enormity of the task ahead.

God has blessed our desire to serve Him this year by providing, yet again, more than we asked for to accomplish the goals we had set out one year ago. We prayed for \$24,000 to be able to build four houses. God has provided, so far, almost \$29,000. Thus, we have the funding to build four houses, cover unexpected costs, and also purchase some equipment (e.g., generators and scaffolding) to be used this year and on future building trips.

When we finish this year's program, we expect, God willing, to have a surplus in our building fund to be used toward the next housing project God directs us to undertake (in Monclova or elsewhere)!

God has also brought forward just the right number of people to accomplish all He has set out for us—61 people will join us for all or part of our week in Mexico.

Please accept our deepest thanks for your wonderful, generous support of these projects!

We ask now that you pray for us every day while we are away—from November 3rd, when my son-in-law and I travel to Jimenez for last minute preparations, through

November 11th, when the last two teams from Harris Creek Baptist Church in McGregor, TX, and from First Baptist Church in Burleson, TX, return home. Please pray:


- for travel mercies;
- for safety during the house building and otherwise;
- that we would all remain free from illness;
- that we would all be God's hands and feet during the trip, providing His love, service, and compassion to all we encounter;
